6 BACKGROUND (Why is this Action Necessary, and What Action will be accomplished)

This is an annual contract to provide services to remove, repair, replace and install fencing throughout Charlotte County on various lands owned or maintained by the County. Orders for work will be placed throughout the year as requirements are identified. This contract also includes time and materials plus a labor rate for maintenance items not identified as a line item for fencing requirements.

Therefore, it is in the best interest of the County to award Bid #14-115, Fencing Maintenance & Repairs - Annual Contract to the lowest responsive, responsible bidder for the period from date of award through and including December 31, 2015 with the option to renew by mutual consent, at the same prices, terms and conditions. Estimated annual usage is from September 28, 2010 to February 28, 2014 was \$198,040.27.
