### Resume'

From 1963 until the late 1980's I was involved in banking in Sarasota County Florida. From 1963 until 1971 I was a commercial loan officer at Sarasota Bank & Trust Company which was part of Ellis Banking Corporation. In 1971 I opened Longboat Key Bank for Ellis Banking Corporation and was president there until 1975 when I became Senior Vice President of Ellis Sarasota Bank & Trust and Executive Vice President of Ellis American Bank, both in Sarasota. In late 1975 I went to North Port Bank on behalf of Ellis Banking Corporation to oversee a merger of North Port Bank into Ellis Banking Corporation. The merger fell through and I elected to leave Ellis Banking Corporation and stay at North Port Bank where I became President & CEO and later Chairman of the Board & CEO. I was in that position until the late 1980's when First Union purchased North Port Bank. As part of the Purchase & Sale Agreement with First Union, I had to sign a three year non-compete agreement specifying I would not be involved in banking in Sarasota County or any County that touched Sarasota County. My wife owned South County Realty in Englewood at that time, so I got my real estate license and worked at South County Realty and Gulf Realty and Associates in the early 1990's. In 1997 I placed my license with Coldwell Banker Sunstar Realty in Englewood and I am still an active realtor with them.
