6 BACKGROUND (Why is this Action Necessary, and What Action will be accomplished)

This is an annual contract to purchase insecticides and herbicides, to be utilized on an "as required" basis by the Public Works-Pest Management Division which the Board approved on July 22, 2014. It was discovered after the award the Crop Production Services made an error in one of their line items, line item #10, Reward, and are unable to honor the prices of \$30.90 per gallon. Therefore, staff recommends rescinding award to Crop Production and awarding Line Item #10, Reward, to Winfield Solutions of Plant City, FL, at the unit cost of \$100 per gallon. This unit price is in line with the other bids received for this item.




